A proposed budget for 2025 was presented, reviewed and scheduled to be approved at the January 13, 2025 meeting.

The scheduled outage on October 26, 2024 was rescheduled for November 2, 2024 between 9:00am – 10:00am. The outage was successful ensuring that the generator would sync with the new remote substation and carry all circuits within the CMLP distribution system.

An update regarding the lawsuit with Michael Farley vs Coggon Municipal Light Plant was given.

On September 18, 2024 the Iowa District Court dismissed the case of Michael Farley VS City of Coggon and Coggon Municipal Light Plant.

On October 2, 2024 Michael Farley filed a motion to reconsider, amend, or enlarge the court's ruling on defendants' motions for summary judgment.

On 10/31/2024 the motion to reconsider was denied by the District Court of Iowa.

On 11/27, 2024 Michael Farley filed an appeal to the Supreme Court of Iowa.

Treasurer McClelland's term ends December 31, 2024. He is requesting the city council reappoint him to another term.

Treasurer McClelland motioned to adjourn at 6:45 pm, Trustee Cooper seconds, five ayes and the motion to adjourn carried.
